Governance

- ▶ The Governance Committee met on February 23, 2017, to review the status of quarter one products and continue discussions on the NCSWIC Intellectual Capital Assessment

Charter Update Working Group

- ▶ Working group members met on February 20, 2017, to finalize the first section of the NCSWIC Charter, including the Background, Mission, and Vision
- ▶ The working group continues to work on the second section of the Charter: Goals, Objectives, Strategic Plan and Membership

Planning, Training, and Exercise

Technology Policy (Joint with SAFECOM)

- ▶ The Technology Policy Committee met on February 21, 2017, to continue discussions on the definition of "Public Safety Grade," which will be featured in a Public Safety Grade White Paper and is intended to be endorsed by the public safety community
- ▶ Members also reviewed and discussed the following work products developed by the Identity, Credentialing, and Access Management (ICAM) Working Group
 - *ICAM Trustmark Framework Position Paper*: The Position Paper encourages the public safety community to leverage and adopt the Trustmark Framework in effort to achieve a federated ICAM solution
 - *ICAM Trustmark Framework Brochure*: The Brochure will accompany the release of the ICAM Trustmark Framework Position Paper and is intended to provide public safety stakeholders with background and supplemental information on the Trustmark Framework
- ▶ Members continue to develop the May 2017 in-person committee meeting agenda

ICAM Working Group

- ▶ The ICAM Working Group met on February 21, 2017 to discuss, finalize, and approve the ICAM Trustmark Framework Brochure and the ICAM 101 Executive Briefing, a two-page fact sheet designed to provide public safety executives and officials with a high-level overview of ICAM
- ▶ Members also discussed and finalized plans to host ICAM Trustmark Framework Webinar on March 16, 2017, at 2pm ET, to educate SAFECOM and NCSWIC members on the Trustmark Framework and will provide members an opportunity to ask questions prior to the Executive Committee votes on the related work products.
- ▶ Members expressed interest developing an index or guide of ICAM reference materials.

Funding and Sustainment (Joint with SAFECOM)

- ▶ The Joint Funding and Sustainment Committee met on February 15, 2017, and received updates on revisions to the SAFECOM Grant Guidance from the Office of Emergency Communications (OEC) National Emergency Communications Plan and Grants Branch
- ▶ Members reviewed and approved the Life Cycle Template to present to the SAFECOM and NCSWIC Executive Committee and discussed adding additional equipment to Estimating the Life Cycle
